As per section 5(ii) of the Sexual Harassment of Redressal of Grievances of Students) Regulations, 2023, at Ref. (2), the Student Grievance Redressal Committee at the University was formed as per Ref. (1) keeping University Grants Commission (Redressal of Grievances of Students) Regulations, 2012 as guidelines. However, with the release of UGC Guidelines a Ref. (2) is necessary to revise the Student Grievance Redressal Committee at the University. ### Terms and Conditions of the Committee

- c) The quorum for the meeting including the Chairperson, but excluding the special invitee, shall be three.
- d) In considering the grievances before it, the SGRC shall follow principles of natural justice.

- e) The SGRC shall send its report with recommendations, if any, to the competent authority of the institution concerned and a copy thereof to the aggrieved student, preferably within a period of 15 working days from the date of receipt of the complaint.
- f) Any student aggrieved by the decision of the Students' Grievance Redressal Committee may prefer an appeal to the Ombudsperson, within a period of fifteen days from the date of receipt of such decision.
